This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of Linocraft Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules (the “**GEM Listing Rules**”) Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

### **DELAY IN PUBLICATION OF THE 2024 INTERIM RESULTS AND DELAY IN DESPATCH OF THE 2024 INTERIM REPORT**

Pursuant to Rules 18.53 and 18.78 of the GEM Listing Rules, the Company must publish the interim results announcement (the “**2024 Interim Results**”) and despatch the interim report (the “**2024 Interim Report**”) in respect of the first six months ended 29 February 2024 not later than two months and three months after the end of the such period respectively. As the Company has not finalized the 2023 Annual Results, thus the Company is unable to publish the 2024 Interim Results and despatch the 2024 Interim Report to the Shareholders within the prescribed time in accordance with the GEM Listing Rules.
